

CODE OF CONDUCT

The Medford Parks, Recreation and Facilities Department (MPRFD) strives to provide an environment that is beneficial to recreation and the enjoyment of all patrons using its facilities. With this goal in mind, the following code of conduct has been established for all patrons of the facility.

Specific programs and activities in the facility may have additional and/or more specific-program rules and guidelines that must also be followed.

EXPECTATIONS OF PATRONS

- Conduct yourself in a manner that is respectful to other patrons, participants, and staff.
- Respect the facility and the property of other patrons. Check with staff prior to using City equipment and/or rooms.
- Follow posted rules, written and/or verbal program-specific rules, and/or the request(s) of a staff person.
- Secure all personal belongings. MPRFD is not responsible for lost and/or stolen items.
- Dress appropriately for a public place. Wearing a shirt and shoes are required in the facility (except in pools and on pool decks).
- All belongings/bags brought into the facility must be carried in a single trip, kept contained, out of the way of others and always within your reach. Do not leave belongings unattended.
- Maintain orderly and safe entry/exit by not slowing or stopping in high traffic-areas, doorways, aisles, and stairways, and keep personal items from interfering with others' access to the facility.
- Limit active play to areas designated for it.
- Clean up after yourself, including putting all trash and/or recyclables in the proper receptacles.
- Park in designated and authorized areas only.

PROHIBITED BEHAVIOR AND ACTIVITIES

- Engaging in disruptive and/or disorderly behavior or conduct that endangers yourself or others and/or damages or defaces property.
- Using profanity or demeaning language, intimidation, taunts, teasing and/or ridicule or any other abusive and/or harassing language or behavior.
- Smoking or using tobacco (in any form), including vaping, inside or outside the Rogue X.
- Using drugs, alcohol, or any other intoxicating substance while at the facility, or be under the influence of such substances while using the facility.
- Bringing animals (except services animals) inside or leaving animals unattended outside the facility.
- Playing personal audio equipment at a volume that disturbs others.
- Riding bicycles or scooters, skate or skateboard inside the facility or leaving these items unattended in the building and/or building walkways.
- Using the restroom for the purpose of shaving, bathing, haircutting, washing clothes or other uses it was not intended for.

- Using the locker room for uses other than changing or showering before or after participation in recreational activities.
- Loitering in the locker room for longer than 15 minutes.
- Leaving young children unsupervised.
- Using cell phones with photographic capabilities in the locker rooms and/or restrooms.
- Camping and/or sleeping at the facility and/or on the grounds.
- Conducting any type of pedestrian interference in a public place, including obstructing pedestrians or vehicular traffic.
- Possessing any weapons without a permit.

The Medford Parks, Recreation and Facilities Department (MPRFD) reserves the right to take immediate disciplinary action, including removal from the facility, for violation(s) of the Code of Conduct. Please be aware some Code of Conduct violations may also subject the violator to criminal prosecution in addition to any sanctions administered by MPRFD.
